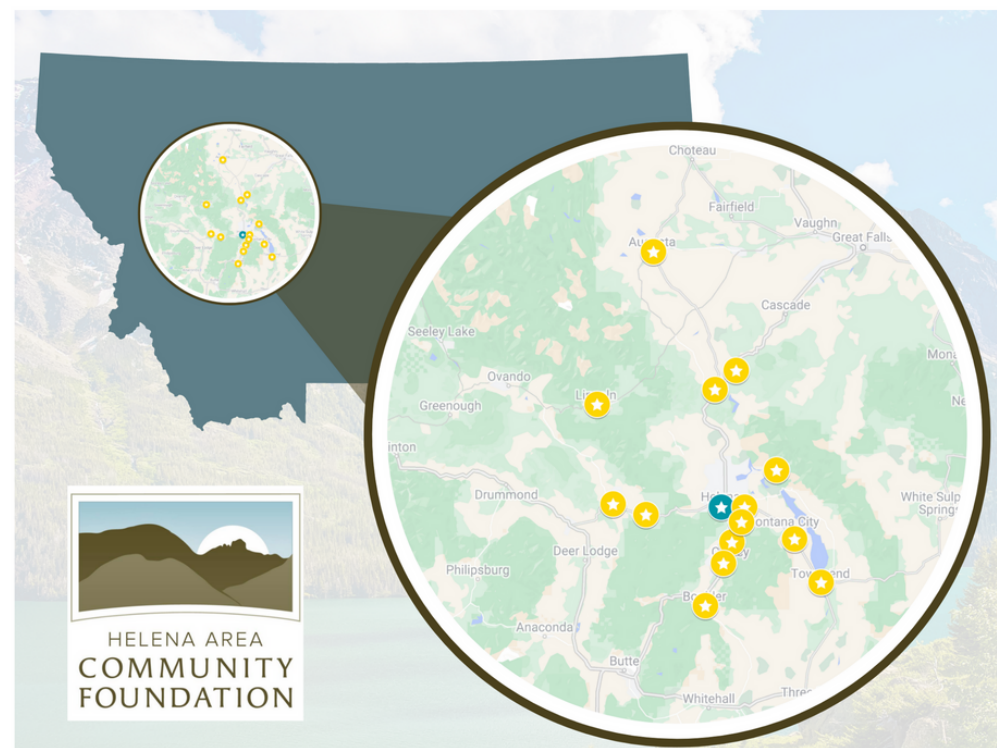

HACF builds and maintains a permanent endowment for the future. Grant Making is Central to HACF's Mission

The Helena Area Community Foundation awards annual grants to local nonprofits as one of the core elements of our programming.

Beginning in 2022, HACF also began granting funds from the City of Helena and Lewis and Clark County in a new partnership designed to support local nonprofits.

We believe that supporting local nonprofits through grant making is the best way to utilize HACF's endowment distribution. At the current levels HACF is granting, we have chosen to focus on projects where a small grant can solve a problem or remove an obstacle.

New partnerships, like those built with the City of Helena and Lewis and Clark County, provide opportunities to increase the amount of funds available to our local community.

As HACF increases the size of our permanent endowments and develops new partnerships, our grant making ability will increase, to the benefit of our communities.

Community Partner Stories

The Myrna Loy's mission is to inspire the people of Helena with innovative, high-quality arts experiences of all kinds; to support Montana artists in their work; to foster a lifelong love of the arts through robust arts education; and to build community through art.

The Myrna Loy shared this story:

"We are developing new family programming to bring high-quality arts experiences to whole families with young children, providing arts experiences in the community to age groups who normally only get arts content on screens. Funding supported two series of New York International Children's Film Festival films for ages 5+, plus a performance especially for young families by indigenous Australian powerhouse singer Emma Donovan. We are continuing to work with the young family community in Helena to develop more high-quality programs that are enticing both to young kids and their whole families. Additionally, this school year our Puppet Artists in the Schools brought a special hands-on puppet arts workshop called "The Hedgehog and the Bear" to every kindergarten class in Helena.

We are also collaborating with AARP Montana to create more community-based opportunities for gatherings and socialization targeted to the 55+ population, who report higher incidences of isolation post-Covid. These activities focus on matinee films (with open captioning), and other social events."

FOCUS IN GRANTING

The 2022 "City of Helena" Fund was distributed to 501(c)(3) organizations in the greater Helena Area, with a priority given to organizations operating within the Helena city limits. Lewis and Clark County Funds can be distributed to organizations in or outside of Helena, Lewis and Clark County, or in regions that serve residents of Lewis and Clark County. Funds had to be used for projects with an expressed public purpose that benefits the residents of the City of Helena or the residents of Lewis and Clark County.

Priority was given to nonprofits who demonstrated a meaningful, specific need that could be fulfilled with a small grant.

Community Partner Stories



Lewis and Clark Humane Society is a small, private, community-based, not-for-profit organization that provides shelter for unwanted and stray animals while working to end pet overpopulation, reduce the need for euthanasia, and improve the humane treatment and well-being of companion animals.

LCHS saw over double the amount of kittens this past year than they did in years before. Kittens require round the clock care and special feeding - especially those who are orphaned. The HACF grant assisted with purchasing specialized food for the nearly 600 neonates that they cared for.

Plymouth Congregational Church made a difference in the lives of our newest neighbors to the Helena community: Afghan refugees.

The funds were used primarily to prepare, plant, water, and maintain a Community Garden plot. The produce that came from the plot was donated to the Afghan refugees who settled in Helena. Because some supplies, soil, plants, and equipment were donated (free of charge), unexpended funds were used to purchase games, toys, school supplies, and winter garments for the Afghan children.

FOCUS IN GRANTING

The 2022 "City of Helena COVID Recovery Fund" was distributed to 501(c)(3) organizations in the greater Helena Area, with a priority given to organizations operating within the Helena city limits.

This funding was specifically earmarked to support nonprofit recovery from COVID-19 related to losses in funding arising from COVID-19 impacts, increased demand for services, tools or equipment needed to retool, changes in community need due to COVID-19 impacts, etc. Local nonprofits were asked to thoughtfully consider the impacts of COVID-19 on their organizations and the community as a whole and to suggest projects or programs that addressed these impacts.

Family Promise of Greater Helena



208 children were sheltered along with their families in 2022. The impact to the children and families was immeasurable. They had a safe, secure warm bed; meals; and clothing through one of the most difficult challenges in their lives. Family Promise assisted them in finding safe and secure housing and will follow up for 24 months to assure their success.

United Way of the Lewis and Clark Area

Both this grant and the matching funds were used to support the staffing for Housing First Helena. Community Impact costs included purchasing supplies for the Shower to Empower program, Helena Resource Advocate cards, and advertising and training costs.

The Showers to Empower program not only supports some of our local unsheltered neighbors with a weekly shower, but they also help support them in other ways. Clients are referred to services, put on housing wait lists, provided shoes and socks, and provided car parts as needed to make their temporary homes usable. Campers have been repaired so that the person living in it can move it every couple of days as is required to stay safe and within the law.

Helena Area Community Foundation (HACF) and United Way of Lewis and Clark Area (UWLCA), (with support from First Interstate Bancsystem Foundation and Phillips 66) opened an Emergency Relief Fund in response to the flash flooding incident on July 3, 2022.

ExplorationWorks

As shared by HACF Executive Director Emily Frazier in our newsletter:

"On July 3rd, Helena experienced flash flooding, on a Sunday night of a holiday weekend--when most offices were closed. On July 4th, HACF and United Way of the Lewis and Clark Area opened a joint emergency relief fund. This is one of the reasons community foundations exist, and we are happy we can be of service to our community in times of need.



And, man, we sure do have a great community. I'd like to tell you one of the stories that has arisen from this particular emergency, which centers on something obscure... Black. Rubber. Mulch.

Prior to July 2022, I had never heard of black rubber mulch, but it turns out it is quite important if you have an outdoor play space for kids. It was an important part of ExplorationWorks' outdoor classroom area, and most of it was swept away during the flash flooding. ExplorationWorks had camps coming up a week after the flooding, so making their camp spaces safe was a high priority.

HACF offered to buy the rubber mulch, and United Way coordinated a team to spread it out. When we went to purchase it, though, we found out something unfortunate. Everyone in Helena was out of black rubber mulch. For that, we needed to go to Billings. So, knowing that volunteers were lined up (thanks PayneWest!), I asked on Facebook if anyone happened to be going from Billings to Helena. And then we got a message from a kind fellow named Roger. Roger wasn't in Billings, but he was willing to go. He picked up 25 bags of black rubber mulch from Lowes in Billings, and dropped it off the next morning at ExplorationWorks. ExplorationWorks was able to safely host campers a week after the flooding."

Helena Area Community Foundation Events

Direct investment into HACF programming benefits our local communities and allows us to host amazing events! HACF presents three main events during the year.



In 2015, HACF introduced the **Steve Browning "Spirit of Philanthropy Award,"** which is given to community members who carry on Steve's commitment to make the Helena area a great place to live, work, play, and raise a family.



HACF hosts **Greater Helena Gives** in early May, a 24-hour online fundraiser to support the nonprofits around Helena. Anyone can easily make a donation to the nonprofit(s) of their choice from a single website.



HACF hosts the annual **Helena Holiday Cruise,** a fun family event to view Helena's Christmas lights from the comfort of your vehicle while enjoying local treats and cocoa!

Margaret says, "Nothing makes better word-of-mouth than generosity. I realized that I had both product and a physical space that could help raise precious dollars for those in need. Having events was fun and brought me deeper into the community. My policy in all business matters became never say no."

Now that Margaret and Jim are retired, they remain committed to volunteering in the community, mainly for Helena Food Share. 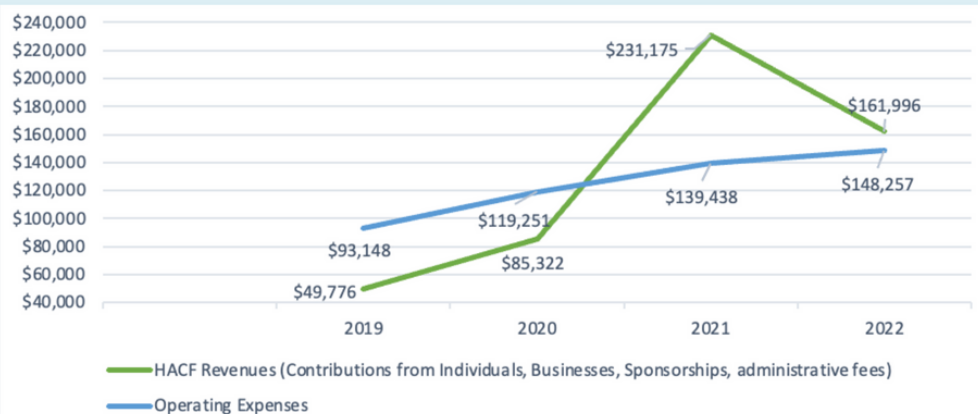

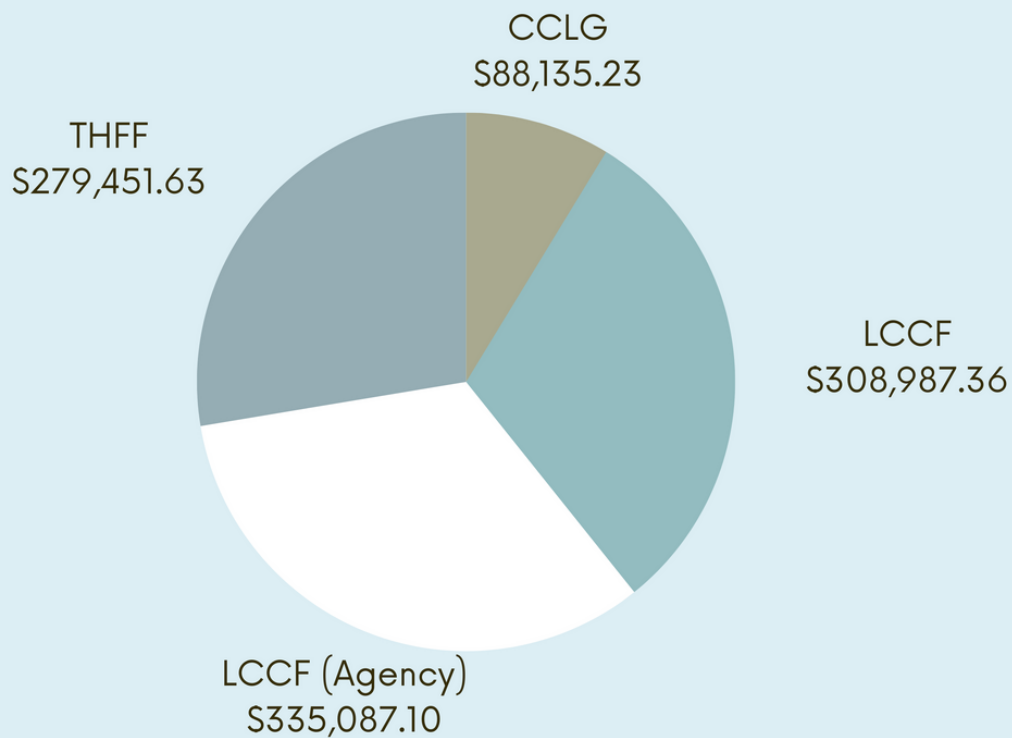
